ORDER:

In the G.O. first read above, orders have been issued constituting the High Power Committee and forming Working Groups for the implementation of the Sustainable Development Goals (SDG) in Tamil Nadu.

2. In the G.O.second read above, amendments have been issued to the orders issued to the G.O. first read above for Working Group No.1 (Goals – 1& 2) and Working Group No.8 (Goals – 16&17). In the G.O. third read above, amendments have been issued to the G.O. first read above for Working Group No.4 (Goals 5&10).

3. In the letter fourth read above, the Principal Secretary to Government, Social Welfare and Nutritious Meal Programme Department and Chairman, Working Group (Women Empowerment and Issues of Inequality) has, inter alia, pointed out that the goals and targets of SDG 10 are applicable to the national level and not relevant to states and the indicators need to be developed at national level. He has also requested to rename the working group as Working Group on Women Empowerment.

4. Government have carefully considered the suggestion of the Principal Secretary to Government, Social Welfare and Nutritious Meal Programme Department and the Chairman, Working Group (Women Empowerment & Issues of Inequality) and decided to accept the same.

5. Government, after taking into consideration the fact that the SDG 10 "Reduce inequality within and among countries" is one which can only be attained by national and international level action, hereby orders that the SDG 10 "Reduce inequality within and among countries" be excluded from the scope of Working Group 4 and that the Working Group 4 be renamed as "Working Group on Women's Empowerment".

6. Accordingly the following amendment to G.O.Ms.No.15, Planning, Development & Special Initiatives (SP.1) Department, Dated 21.03.2017 is issued as detailed below:
